A candidate's questionnaire score and/or past voting record and legislative efforts were taken into consideration before a final grade was assigned to a candidate. CRPA candidate ratings are solely based on a candidate's position on Second Amendment and hunting related issues.

FTAQ: Indicates that the candidate was sent a CRPA questionnaire and failed to answer the questionnaire. As a result, CRPA was unable to evaluate the candidate's position on firearms and hunting-related issues.

Q: Indicates that the candidate returned a completed questionnaire. For example, Q/A indicates that a candidate completed a questionnaire and received an "A" rating from CRPA.

A+: Indicates an elected official who has an excellent voting record and who has made a significant effort to defend the Second Amendment and hunting issues.

A: Indicates a pro-gun candidate who strongly supports CRPA positions on Second Amendment and hunting-related issues.

B: Indicates a candidate that supports Second Amendment and hunting-related issues in most instances.

C: Indicates a candidate that supports some CRPA positions but is not consistently a pro-gun or pro-hunting candidate.

D: Indicates an anti-gun and anti-hunting candidate who is not supportive of CRPA positions.

F: Indicates a vehement anti-gun candidate. If the candidate is an incumbent they always oppose gun owner's rights and/or actively support or sponsor anti-gun and anti-hunting legislation.

*****: Indicates that the assigned grade is based on candidate's voting record as it relates to the Second Amendment and hunting issues.

<>: Candidate ran uncontested in Primary Election.
