Ammunition, BB Devices, archery, sling shots, tomahawks, Dietary issues and Access to CRPA Premises and Events**

I, the undersigned parent or legal guardian of _____,

a minor, do hereby give my child express permission and consent to be lent and to be in possession of a firearm(s) and ammunition provided by the California Rifle & Pistol Association, Incorporated ("CRPA"), by a Federal Firearms Licensee(s) affiliated with the CRPA, or by staff or members of the CRPA, for the purpose of allowing my child to engage in lawful, recreational sport, including participation in instruction in the safe handling and shooting of firearms, in target shooting, or in related firearms activities conducted under the supervision of the CRPA or under the supervision of CRPA/ NRA-Certified instructors and range staff retained by the CRPA for purposes of providing such a program to my child and other children. (Cal. Penal Code §§ 27945, 29615, 29650, & 29655; and 18 U.S.C. § 922(x)). I also expressly give permission and consent for my child to participate in other event activities on the Premises which may be provided by CRPA or an independent vendor as part of a CRPA hosted event.

I understand that for the purposes of this consent, "firearms" includes any handguns, long guns, or shotguns that may lawfully be possessed by a minor under state and federal law. I also give my child express permission and consent, pursuant to California Penal Code section 19915, to possess a "BB device" as defined in California Penal Code section 16250, during any CRPA event where a BB device is used as part of a program provided to children.

This consent will remain in effect for my child from the date of my signature below until ten days thereafter for purposes of my child's participation with, lending of, or possession of a handgun. This consent will remain in effect for my child from the date of my signature below until 30 days thereafter for purposes of my child's participation with, lending of, or possession of a long gun. This consent will remain in effect for my child from the date of my signature below until one year thereafter for purposes of my child's participation with, lending of, or possession of a BB device. I understand that I may revoke this consent at any time. This consent will only apply to firearms, ammunition, BB devices, archery, sling shots, or tomahawks lent to or possessed by my child during any CRPA event where a firearm, ammunition, BB device archery, sling shots, or hawks is used as part of a program provided by CRPA, and will not be valid for any other firearms related activity conducted during any time period this consent is otherwise valid. A photocopy or facsimile of this written consent will serve as an original. This written consent form will be in my child's possession at all times while he or she possesses any firearms, ammunition, or BB devices, except that during any event where my child is participating in a firearms related activity, this consent may be taken into the possession of CRPA staff /instructors for safekeeping and returned to my child at the conclusion of that activity.

I grant CRPA and its principals, members, employees, agents, contractors, volunteers, directors, successors, and assignees (hereinafter collectively the "Related Parties"), the right to take photographs, video, and other media of my child and property in connection with participation in a CRPA hosted or sponsored event. I authorize CRPA and Related Parties to copyright, use, and publish the same in any form in the course of business. I agree that I, nor my minor child will have no control related to the publication, however all recorded images of my child, with or without name, must be used for lawful purposes. I HEREBY RELEASE AND DISCHARGE CRPA AND RELATED PARTIES FROM ANY CLAIM, LIABILITY, AND DEMANDS ARISING OUT OF OR IN CONNECTION WITH THE RECORDING OF AND USE OF IMAGES, INCLUDING, BUT NOT LIMITED TO, CLAIMS OF DEFAMATION AND PRIVACY.

**Parental or Legal Guardian Permission, Release, Waiver, Hold Harmless, and Indemnity Agreement for Minor's Use of
Firearms, Ammunition, BB Devices, archery, sling shots, tomahawks, Dietary issues and Access to CRPA Premises**

In consideration for allowing my child access to the CRPA BB Range and any other affiliated range or property on which CRPA activities occur (collectively the "Premises") and for my child to participate in a live ammunition or projectile firing event presented by the CRPA, I, for myself, my legal representatives, successors, heirs, and next of kin, with regard to my minor child's participation, I VOLUNTARILY AGREE TO EXEMPT and relieve the CRPA, and Related Parties, from liability for personal injury, property damage, or wrongful death caused to my minor children by the act or omission of any of them or of another. I also AGREE TO DEFEND, INDEMNIFY, and HOLD HARMLESS CRPA and any of the Related Parties from and against all claims, losses, damages, and costs caused by, arising out of, or related to the actions or omissions of my child who I bring or allow onto the Premises or who participate in a CRPA-sponsored or affiliated event, and further AGREE TO DEFEND, INDEMNIFY, and HOLD HARMLESS CRPA and any of the Related Parties from and against all claims, losses, damages, and costs arising out of or related to claims brought by or on behalf of any minors whom I bring or allow onto the Premises or who I allow to participate in a CRPA-sponsored or affiliated event on the Premises. But for my agreement to defend, indemnify, and hold CRPA harmless from all such claims regarding or involving minors, the CRPA would not allow me to bring such minors onto the Premises, allow such minors to participate in live ammunition firearms activities on the Premises, or allow such minors to participate in events sponsored by or affiliated with CRPA. The obligation I undertake includes the obligation to immediately defend CRPA from any and all such claims and I assume all risk of the activities of any minor identified herein.
