CRPA starts its 150th year of serving California's Second Amendment Community and is the leader in firearms safety education, conservation and competitive shooting since its inception. Looking forward to the next few years as we take back California.

Defeated Legislation since January 2024. (9 Bills)

Assembly Bills - Started with 16 bills being opposed. Five bills have been defeated, several are heavily amended, and the next four weeks will decide their fate.

June 15 Budget Bill must be passed by midnight (Art. IV, Sec. 12(c)(3)).

June 27 Last day for a legislative measure to qualify for the Nov. 5 General Election ballot (Elections Code Sec. 9040).

July 3 Last day for policy committees to meet and report bills (J.R. 61(b)(13)). Summer Recess begins upon adjournment provided Budget Bill has been passed (J.R. 51(b)(2)).

Aug. 5 Legislature Reconvenes from Summer Recess (J.R. 51(b)(2)).

Aug. 16 Last day for fiscal committees to meet and report bills (J.R. 61(b)(14)).

Aug. 19-31 Floor Session only. No committees, other than conference and Rules committees, may meet for any purpose (J.R. 61(b)(15)).

Aug. 23 Last day to amend on the floor (J.R. 61(b)(16)).

Aug. 31 Last day for each house to pass bills. Final Recess begins upon adjournment.
