## **Five Days before Session ends!!!**

This week I give you the status of bills in play and list the two year bills we may have to deal with in January 2026.

AB1078 – Berman- 3 in 30 despite the ruling in Nguyen v. Bonta and includes pistols and centerfire rifles but not shotguns. (Note-This is how they got it passed as several members of the legislature use shotguns for sport).

AB 1127 – Gabriel – Glock Ban Bill moves forward.

AB 1263 – Gibson – Ghost Guns moves forward.
